MINUTES OF THE 39TH ANNUAL GENERAL MEETING OF ST. XAVIER'S COLLEGE (CALCUTTA) ALUMNI ASSOCIATION HELD ON TUESDAY, 23rd SEPTEMBER, 2025 AT 6:00 PM AT FATHER DEPELCHIN AUDITORIUM

The attendance as per the Attendance Register.

Mr. Firdausul Hasan, Hony. Secretary of the Association welcomed the House and requested Rev. Dr. Dominic Savio, SJ, President of SXCCAA, to chair the meeting and also requested him to conduct the proceedings of the Annual General Meeting. He requested Rev. Dr. Peter Arockiam, SJ, Vice-Principal, Commerce (Evening) and Treasurer to offer the Prayer.

The quorum being present. The President called the AGM to order.

Rev. Fr. President was felicitated with a floral bouquet by Mr. Umesh Goenka. Rev. Fr.
